Objective of meeting

- Encourage people to take action

- Begin the process to determine if LOPC should advocate for those impacted.



Atfaluna Society for Deaf Children Serving the deaf community in the Gaza Strip

- US was the largest contributor to UNRWA on which Palestinians rely upon for health, welfare and education
- All funding was stopped in Jan of 2024 and remains defunded
- Since Oct 2023 US provided \$641M of aid to Palestinians by USAID
 - This has been suspended including funding for tents and necessities
- Atfaluna's entire school/vocational training facility has been destroyed, founding members and their families have been killed



Church World Services (CWS)

Refugee resettlement, working for a world where everyone has a safe place

- 1,300 families) 90% are children
 - Families are in limbo
- No longer receiving new arrivals due to program cancelation
- Local staff has been furloughed (28 now 7)
 - Services now reduced to immigration legal services, anti-trafficking



Provide services to legal asylum seekers here in Contra Costa County (over

support, domestic violence support, health and housing navigation



Democratic Republic of the Congo Focusing on education and trauma healing and advocacy support

- DRC was the largest recipient of aid from USAID (\$910M in 2024)
- USAID funds provided learning services to over 350,000 children in conflict zones
- USAID funded advanced health projects, life-saving humanitarian assistance, economic growth and protection of the environment
- With less economic aid more children will be taken out of schools to work for the family, ending the growth in school attendance, especially for girls



Contra Costa & Solano Food Bank Focusing on nourishing our neighbors

- Funding for Local Food Purchasing Assistance Cooperative has ended and the funding for The Emergency Food Program was cut.
 - Reducing the quantity of fresh food, impacting the health of their clients
 - The reduction will mean less food to clients, when household budgets are stretched thin.
- The CalFood program was cut from \$62M to \$8M (87%)
- Historically, food bank usage rises during economic downturns, inflationary periods and uncertain times.



Extended Families Program

Assisting recently unhoused and refugee families by providing basic items

- Expecting reductions on refugee referrals, but will continue to support Nights
- Was expecting to furnish 10 apartments in 2025 for refugees. CWS lost here; EFP covered the cost of new beds and bedding.

unhoused referrals from Shelter Inc, Veterans Administration and Winter

funding from Federal Refugee Resettlement program after 4 families arrived

These funds were not budgeted for that use, has significantly impacted EFP's



Hope Solutions

- finalization. However 82% of staff in HUD offices are targeted to be immediately reduce services

Working to end homelessness, with housing and support services

 80% of funding is from all three levels of government. \$4.3M waiting for dismissed. If funding is not finalized or becomes reduced, HS will have to

Due to lumber tariffs, cost of new cottages for homeless youth increased

Grant proposals were recently cut due to uncertainty in the stock market



Kapnek Trust

Reducing the impact of HIV/AIDs in Zimbabwe


- USAID contracts to Kapnek have been stopped all testing and treatment for disease has ceased. Kapnek's budget cut 75%.
- In 2024 Kapnek tested
 - 135,000 people for HIV/AIDs 12,000 now in treatment
 - 195,000 for TB 3,500 started treatment
 - 29,000 for Cervical Cancer 900 started treatment
- Zimbabwe is low on in-stock TB preventive medicines especially drug resistant TB medicines.
- Diseases know no political boundaries



Monument Crisis Center

Provides food, education, assistance, referrals to at risk and low income families

- Rumors of ICE agents have kept many clients from picking up food
- Funding from State, County and Cities that originates from the Federal level is a big concern
- However 51% of MCC's funding is from individuals, unlike many non-profits
- Commodity food stuffs provided by the Federal government and distributed via the Food Bank are in jeopardy, impacting the agricultural industry
- Very concerned about impact to SNAP (formerly Food Stamps)



STAND!

Breaking the multi-generational cycle of family violence

- Feeling the pressure from a constantly shifting landscape of funding
 - Private foundations are changing priorities away from domestic violence
 - Expecting Federal funds to be drastically reduced if not completely eliminated
 - In 2024 Federal funds for victims of crimes was reduced but California backfilled it for a year.
 - Local funds are derived from Federal funding sources, so impact could magnify
- If STAND!'s budget is cut, staff will be reduced and services will be a bare minimum
